"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, being on the Southern side of Potomac Avenue, in the City of Greenville, being known and designated as lot No. 250 and the Eastern half of lot No. 249, as shown on plat of Pleasant Valley, recorded in Plat Book P, at Page 92, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southern side of Potomac Avenue, at joint front corner of lots Nos. 250 and 251, said pin being 279.9 feet Southwest of iron pin on the southwest corner of the intersection of Potomac Avenue with Prosperity Avenue; thence S. 0-08 E. 130 feet to an iron pin at joint rear corner of lots Nos. 250 and 251; thence N. 29-29 W. 19.6 feet to iron pin; thence S. 61-57 W. 90.35 feet to iron pin in center of rear line of lot No. 249; thence N. 0-08 W. 154.6 feet to iron pin in center of front line of lot No. 249; thence along southern side of Potomac Avenue, N. 89-52 E. 90 feet to iron pin at joint front corner of lots Nos. 250 and 251, the point of beginning."
