WHEREAS, I the said Bennie F. Brown

in and by certain promissory note in writing of even date with these Presents, sem well

and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of

Fifteen Hundred----- (\$ 1500.00) Dollars,

with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to

bear interest at the same rate, to be repaid in installments of

C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor—in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Citizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in

Chicks Springs Township, Greenville County, State of SouthCarolina, lying on the west side of Forest Street, near the City of Greer, and west therefrom, being all of Lot. # 2, on plat of property made for the Wash Miller Estatu by H. S. Brockman, Surveyor, dated November 20, 1948, recorded in the R.M.C. office for Greenville County in Plat Book V., at page 13 and having the following courses and distances:
