NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, near Geer Highway, also known as Cleveland Ave ue, in the Village of Marietta, being shown as Tract No. 3, on Plat of Property of Daisy B. Cleveland made by W. J. "iddle, in May 1948, recorded in Plat Book V, at Page 15, and described as follows:

*BEGINN ING at a stake which is S. 72-00 W. 197.5 feet from a County Road, at corner of Tracts Nos. 2 and 4, and running thence with the line of tract No. 2, S. 22-30 W. 234 feet to a stake at corner of tract No. 1; thence with the line of tract No. 1, S. 5-50 W. 556 feet to a stake in line of property of D. P. Bates; thence with the line of said property, S. 83-00 W. 911.2 feet to a point in a branch; which is 15 feet East of a stake; thence with said branch as the line, the traverse of which is N. 7-50 E. 748.3 feet to a point in branch at corner of tract No. 4, which is 39.8 feet East from a stake; thence with the line of Tract No. 4, N. 83-00 E. 1132.5 feet to the beginning corner, containing 17.51 acres, more or less."

Together with a right of way for egress and ingress over tract No. 4.
