to be paid in full One Year after date and in monthly
payments of **Forty(\$40.00) Dollars** per month during said time

with interest thereon from date

at the rate of **6** per centum per annum, to be computed and paid **Srmi-annually**

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

sold and released, and by these Presents do grant, bargain, sell and release unto the said **E.H.Edwards, and**

his heirs and assigns forever, all of that certain, piece, parcel or lot of land situate, lying in being in said State and County, Chick Springs Township, near the Town of Taylors, and having the following metes and bounds, to-wit: -BEGINNING at a stake on the corner of lot No. 65 and running thence N. 18 W. 150 feet to a stake; thence N. 71.45 E. 25 feet to a stake; thence S. 18 E. 150 feet to a stake on the National Highway; thence along said Highway S. 71.45 W. 25 feet to the beginning corner, and being the western half of lot No. 66 as shown by Plat of The Alfred Taylor Property, surveyed by W.A. Adams, Surveyor, January 1913 and containing 3750 square feet of land, more or less, and being all of the same lot of land conveyed to me this day by Mrs. Willie Mae Jones Harrill and Mrs.
