to The Federal Land Bank of Columbia, securing the payment of the principal sum of ~~----Forty-Four Hundred-----~~ (\$ 4400.00) Dollars, dated the ~~--23--~~ day of ~~--March--~~ 19 49 , and recorded in the public records of ~~-----Greenville-----~~ County, State of ~~--South Carolina---~~, in ~~-Mortgage-~~ Book ~~---419--~~, at page ~~--551---~~, the following described property, to-wit:

All that piece, parcel and lot of land lying and being on the Greenville-Asheville Highway in Saluda Township, Greenville County, South Carolina, and being a portion of the land conveyed to B. C. Poole by W. H. Ambler by deed recorded in Deed Book , Page , and containing fifteen (15) acres, more or less. The identical land here conveyed begins in the center of the Greenville-Asheville Road near a branch at Lindsey's lands and runs thence along Lindsey's line North 37 degrees 28 minutes West 1730 feet to a rock on lands of Saluda Land & Lumber Company; thence along line of Saluda Land & Lumber Company South 28 degrees West 360 feet to rock; thence by a new line between B. C. Poole and the property here conveyed South 33 degrees East 1600 feet to corner on Greenville-Asheville Highway; thence along said highway North 52 degrees 30 minutes East 520 feet to the beginning corner; a plat of the B. C. Poole property is recorded in Plat Book V, Page 117, and the property here conveyed is cut from the Southwest side of that plat.

ALSO: - All that piece, parcel and lot of land lying and being in Saluda Township, Greenville County, South Carolina, on the Western side of the Greenville-Asheville Highway, containing thirteen and six-tenths (13.6) acres, more or less, and being a portion of the lands conveyed to B. C. Poole by W. H. Ambler by his deed recorded in Deed Book , Page , R.M.C. Office, Greenville County. A plat of the Ambler property as conveyed to B. C. Poole is recorded in said office in Plat Book V, Page 117. The lands here conveyed consist of a triangular tract cut from the western side of the Poole tract and begin at a corner in branch adjoining J. C. Morgan on the Greenville-Asheville Highway and runs thence along said highway North 52 degrees 30 minutes West 800 feet to corner; thence North 63 degrees West 1895 feet to a rock; thence South 39 degrees 30 minutes East 793 feet to corner in Burton's Branch; thence along said branch South 39 degrees East 600 feet to abrupt bend in branch; thence South 39 degrees West 66 feet to another abrupt bend in branch; thence South 29 degrees East 278 feet to the corner in the Greenville-Asheville Highway at beginning.
