SEND GREETING:

Whereas, I, the said R. B. Vaughn  
in and by my certain promissory note in writing, of even date with these  
Presents, am well and truly indebted to Allen E. Vaughn  
in the full and just sum of Six Thousand Dollars(\$6000.00)  
to be paid Five Hundred Dollars(\$500.00) each year

with interest thereon from date  
at the rate of six per centum per annum, to be computed and paid annually  
until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to  
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that piece, parcel and lot of land lying and being in County  
and State aforesaid, on the Overbrook Road and Balsom Road, Greenville  
Township, and being the northern and eastern portion of lot number 46  
as shown on a plat recorded in Plat Book E, page 252, and being the  
identical portion of that lot conveyed to R. B. Vaughn by Allen E.  
Vaughn by deed dated February 28, 1948, recorded in Deed Book 337,  
Page 405, R. M. C. Office, Greenville County. And being likewise the  
same land mortgaged by the said R. B. Vaughn to the Fidelity Savings  
and Loan Association under date of May 17th, 1950 recorded in Mortg. Book
