SEND GREETING:

Whereas, we, the said Harry M. Campbell and Stella M. Campbell  
in and by our certain promissory note in writing, of even date with these  
Presents, are well and truly indebted to The South Carolina National Bank, Trustee  
under agreement with F. W. Symmes dated October 21, 1946  
in the full and just sum of Five Thousand and no/100 (\$5,000.00) Dollars

, to be paid as follows: Seven Hundred Fifty Dollars on September  
12, 1951, and a like amount each year thereafter up to and including September 1,  
1956, with the balance due to be paid on September 1, 1957. Right to anticipate  
payment in whole or part reserved, provided such anticipated payment is made on  
interest payment date.

, with interest thereon from date  
at the rate of five per centum per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to  
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

sold and released, and by these Presents do grant, bargain, sell and release unto the said The South Carolina  
National Bank, Trustee under agreement with F. W. Symmes dated October 21, 1946, its  
successors and assigns:

All that certain piece, parcel or lot of land, with the buildings and improvements  
thereon, lying and being on the northerly side of James Drive, near the City of Green-  
ville, S. C., and being designated as Lot No. 6 on the Plat of Orderest Park recorded  
in the RMC Office for Greenville County, S. C., in Plat Book "S", page 109, and hav-  
ing according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of James Drive, joint front corner of  
Lots Nos. 6 and 7 and running thence along the common lines of said lots N 8-16 W  
160 feet to an iron pin, joint rear corner of said lots; thence along the rear of  
said lot no. 6 N 81-44 E 65 feet to an iron pin, joint rear corner of lots 5 and 6;  
thence along the common line of said lots S 8-16 E 160 feet to an iron pin on the  
northerly side of James Drive, joint front corner of said lots; thence along the  
northerly side of James Drive S 81-44 W 65 feet to the point of beginning.
