I, Clarence Southerland

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Hundred Fifty and No/100

DOLLARS (\$ 750.00),

with interest thereon from ~~date~~ maturity at the rate of Six per centum per annum, said principal and interest to be repaid: \$30.00 on September 12, 1950, and a like payment of \$30.00 on the 12th day of each month thereafter until one year after date at which time the unpaid balance will be due and payable, with interest thereon from maturity at the rate of Six (6%) per cent, per annum, to be computed and paid monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Saluda Township, on the Northern side of a County Road, leading from Mush Creek Church Road, to Maridell School, and bounded on all sides by lands of W. M. Howard, and described as follows:

"BEGINNING at a nail in the road, and running thence N. 4-00 E. 208.7 feet to an iron pin; thence N. 67-38 W. 208.7 feet to an iron pin; thence 3-07 W. 208.7 feet to nail in road, witnessed by iron pin on line; thence with road, S. 59-22 E. 108.7 feet to a bend; thence S. 76-00 E. 100 feet to the beginning corner, containing 1 acre more or less."
