"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Cleveland Township, on the Eastern side of Cleveland Avenue, in the Town of Marietta, being the Southern portion of the original old hotel lot, and being designated as "Hotel Lot" on plat of the property of J. Norwood Cleveland and Estate of R. Mays Cleveland, made by W. M. Rast in June 1927, and described as follows:

"BEGINNING at a stake on the Eastern side of Cleveland Avenue, corner of other property of the mortgagor (designated as the B. F.
