NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on Paris Mountain Avenue, in that section known as San Souci, about two miles North of the City of Greenville, said lot having the following lines, courses and distances:

"BEGINNING at an iron pin on the Southern side of a 5-foot sidewalk running along Paris Mountain Avenue, said pin being the joint front corner of Lots Nos. 22 and 23, and running thence along the line of Lot No. 22, S. 5-35 E. 180 feet to an iron pin in line of Lot No. 9; thence along the rear line of Lot No. 8, S. 84-28 W. 75 feet to an iron pin on line of Lot No. 8; thence along line of Lots Nos. 8 and 24, N. 5-35 W. 180 feet to iron pin on southern edge of sidewalk running along Paris Mountain Avenue, said pin being the joint front corner of Lots Nos. 23 and 24; thence with the Southern edge of said sidewalk, N. 84-28 E. 75 feet to the beginning corner. Said lot being known and designated as Lot No. 23 as shown on Plat of Property of Ethel Y. Perry Estate, recorded in Plat Book B at Page 33."
