Whereas, I the said Charlie B. Davis

All that lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as lot No. 24, as shown on a Plat of Royal Heights, recorded in Plat Book W at Page 25, and being more particularly described according to a recent survey by R. W. Dalton September, 1950, as follows:

BEGINNING at an iron pin on the Southeast side of Irene Circle, which pin is 179.6 feet Northeast of the turn of Irene Circle and is the joint front corner of lots 24 and 25, and running thence with Irene Circle, N. 44-24 E. 78.8 feet to an iron pin, joint front corner of lots 23 and 24; thence with joint line of said lots, S. 63-53 E. 122.9 feet to an iron pin in line of lot 22; thence with line of said lot, S. 26-07 W. 75 feet to an iron pin, joint rear corner of lots 24 and 25; and running thence with joint line of said lots, N. 63-53 W. 147.5 feet to the beginning corner.
