"BEGINNING at a point on the Southern side of Mayflower Street, joint front corner of Lots 9 and 10, which iron pin is also 105 feet in an Easterly direction from the Southeast corner of the intersection of Mayflower Street and Elberta Street, and running thence with the line of Lot 10, S. 47-08 E. 170 feet to a point in the line of Lot #29; thence with the line of Lot 29, N. 53-52 E. 106.8 feet to a point, joint rear corner of Lots 7, 14, 15 and 29; thence with the line of Lots 14, 13 and 6, N. 47-08 W. 190 feet to a point on the South side of Mayflower Street, joint front corner of Lots 6 and
