C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, located near Pleasant View Baptist Charch, on the West side of the Rutherford Road, being bounded on the North bymlands of Steadman, on the East by the said road, on the South by lands formerly of Walter Smith Estate (now of Douglas E. Greer) and on the West by W. H. Langley, having the following courses and distances, to wit:-

BEGINNING on a stone, old corner, and joint corner of the Douglas E.
