All that piece, parcel or lot of land in Grove Township, Green-ville County, State of South Carolina, containing 14.10 acres more or less, as shown by Plat of the property of J. K. Keller, made by J. Coke Smith February 11, 1945, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of a 30 foot road leading off from the Greenville-Piedmont Highway, at joint corner of property of J. K. Keller and W. L.
