all that tract or lot of land in Greenville Township, Greenville County, State of South Carolina, being located on the southwest side of the public highway leading from Greenville to Easley and having the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of said highway, joint corner of other property now or formerly of Minnie V.
