C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Grove Township, being known and designated as Lot No. 5 of the property of W. C. Kilpatrick according to plat made by W. J. Riddle, Surveypr, September 1949, and having the following courses and distances, to wit:-

BEGINNING at a stake on the South side of Highway known as the Old Georgia Road, at the joint corner of Lots 4 and 5, and running along the line of Lot No. 4 S 28-22 E 179.8 feet to a stake on property of W. C. Kilpatrick; thence along the W. C. Kilpatrick line N 76-58 E 78.5 feet to a stake at the joint rear corner of Lots 5 and 6; thence along the line of Lot No.6 N 22-30 W 177 feet to a stake on the Old Georgia Road; thence along said Road 8 77-10 W 100 feet to the beginning corner.
