I, C. Morris Kelley, of Greenville County,..... SEND GREETING:

WHEREAS, I the said C. Morris Kelley.....

in and by my certain promissory note, in writing, of even date with these presents, well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of Six Thousand, Seven Hundred, Fifty and No/100 (\$6,750.00...)

Dollars, with interest at the rate of six (6%) per centum per annum, to be repaid in instalments of.....

Fifty-One and No/100 (\$51.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me, the said.....

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of ... Greenville, Greenville Township, within the corporate limits of the City of Greenville, being known and designated as a part of Lot No. 40 of a subdivision known as Vista Hills, a plat of which is of record in the R. M. C. office for Greenville County in Plat Book P, at page 149, and having the following metes and bounds, to-wit:

"BEGINNING at a point at the southeastern intersection of Ashton Avenue with Ridgecrest Drive, and running thence with the Eastern side of Ashton Avenue, S. 37-44 E. 68 feet to a point; thence continuing with the Eastern side of Ashton Avenue, S. 18-31 E. 99 feet to a point; thence N. 65-20 E. 116.4 feet to a point at the joint rear corner of Lots Nos. 40 and 41; thence along the joint line of said lots, N. 39-15 W. 190 feet to a point on the southeastern side of Ridgecrest Drive at the joint front corner of Lots Nos. 40 and 41; thence with the southeastern side of Ridgecrest Drive, S. 50-45 W. 75 feet to the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
