"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, situate on the East side of Henderson Street, and being known and designated as all of lot No. 54 and the northern one-half of lot 53 of Section "A", of a subdivision known as City View, as shown on plat recorded in Plat Book A at Pages 460 and 461, and described as follows:
