All that certain lot or parcel of land situate, lying and being in the City of Greenville, County and State aforesaid on the eastern side of Rutherford Street and having a frontage of 53' 3" on said street and 169' on Stone Avenue and being better known and designated as lot 1 in section "E" of the Stone Land Company subdivision as shown on plat recorded in the R. M. C. Office for Greenville County in Plat Book "A", pages 337 to 345.

Also all that piece, parcel or lot of land in Greenville Township, Greenville County, state of South Carolina, in the City of Greenville, on the east side of Rutherford Street and being known and designated as lot 3 and a portion of lot 4 as shown on plat of the property of Stone Land Company, recorded in the Office of R. M. C. for Greenville County in Plat Book A, page 337 and being more particularly described according to said plat as follows:

BEGINNING at a point on the east side of Rutherford Street joint corner of lots 2 and 3 and running thence S 83-13 E 171' to an alley; thence along said alley S 0-5 W 60' to a point in an 18' alley; thence N 85-55 W through said alley and through lot 4 as shown on said plat 172' more or less to a point on the east side of Rutherford Street; thence with said street N 1-41 E 60' to the beginning corner, and being same lot of land conveyed
