"BEGINNING at an iron pin on the south side of Marion Road at the corner of Lot No. 76, and running thence along the south side of Marion Road, S. 36-30 W. 28.2 feet to an iron pin at a bend in said road; thence still along the south side of Marion Road, S. 70-30 W. 46.8 feet to an iron pin in the center of the front line of Lot No. 78; thence on a new line through the center of Lot No. 78. S. 29-30 E. 200 feet, more or less, to an iron pin in the center of the rear line of Lot No. 78; thence N. 46 E. 75 feet to an iron pin at the rear corner of Lot No. 76; thence along the line of that lot, N. 28-30 W. 184.7 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
