I, John A. Heaton, of Greenville County,..... SEND GREETING:

WHEREAS, I, the said, John A. Heaton.....

in and by... my... certain promissory note, in writing, of even date with these presents..... am... well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full

and just sum of... Five Thousand, Eight Hundred and No/100... (\$5,800.00...)

Dollars, with interest at the rate of ~~six (6%)~~ four (4%) per centum per annum, to be repaid in instalments of.....

Thirty-Five and 15/100... (\$ 35.15.....) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of... Greenville., in the City of Greenville on the western side of Brookview Circle, known as Lot No. 3 according to a plat of property of H. C. Gibson, recorded in the R. M. C. office for Greenville County, said lot having the following metes and bounds:

"BEGINNING at an iron pin on the western side of Brookview Circle and running thence S. 77-56 W. 150.1 feet; thence S. 15-51 W. 62.2 feet; thence N. 77-56 E. 178.2 feet; thence along Brookview Circle, N. 11-00 W. 55 feet to the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same lot of land conveyed to me by Mary C. Gibson by deed of even date herewith, not yet recorded.

"The plat above mentioned is recorded in Plat Book Z, at page 147, and the above described lot is the northern portion of Lot 53 and the southern portion of Lot No. 52 of a subdivision known as Shannon Terrace, according to a plat thereof recorded in Plat Book L, at page 91."
