receipt of which is hereby acknowledged, Metropolitan Life Insurance Company

does hereby release forever the property described below from the lien of
that certain mortgage dated February 10, 1947, executed by K. B. Miles in
favor of C. Douglas Wilson & Co. and assigned to Metropolitan Life Insurance
Company, which mortgage is recorded in the R. M. C. Office for Greenville

(formerly known as Kenwood Drive), which iron pin is 15 feet in a
Westerly direction from an iron pin at the joint front corner of
Lots Nos. 10 and 12 and in the front line of Lot No. 12 and running
thence N. 1-18 E. 150 feet to an iron pin in the rear line of
Lot No. 12, which iron pin is 15 feet in a Westerly direction from
the joint rear corner of Lots Nos. 10 and 12; thence N. 89-32 W.
5 feet to an iron pin in the rear line of Lot No. 12; thence
S. 1-18 W. 150 feet to an iron pin on the North side of West Pine-
hurst Drive; thence along the North side of West Pinehurst Drive
S. 89-32 E. 5 feet to an iron pin, the point of beginning.
