(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest, Travelers Rest, S.C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Hundred Fifty and No/100-

maturity DOLLARS (\$ 550.00),
with interest thereon from ~~date~~ at the rate of six per centum per annum, said principal and interest to be repaid: in monthly installments of \$50.00 each on the 11th day of each month hereafter until paid in full, with interest thereon from maturity at the rate of Six (6%) per cent, per annum, to be computed and paid annually.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, lying on the East side of G & N R R and bounded by lands of Henry Taylor, Lonnie E. Tester, John Landers and other land of Bessie Swaney, containing two and no/100 acres, more or less, with metes and bounds, to-wit:

"BEGINNING at center of R. R. tracks of Taylor's corner and running thence with R.R. S. 39-00 E. 240 feet; thence N. 80-00 E. 436 feet to stake on Landers line; thence N. 43-00 W. 247 feet to stake on Boyd's corner; thence S. 80-00 W. 414 feet to the beginning corner.
