Lot No. 1: Being on the Southwest side of John Street, in the City of Greenville, and having the following metes and bounds:

BEGINNING at a stake on John Street, corner of Charles McAlister; thence with John St. N. 67 W. 1.062 chains to lot now or formerly of T. W. Davis; thence with line of T. W. Davis S. 182 W. 90 feet to stake; thence with my line S. 67 E. 1.062 chains to corner of Charles McAlister; thence N. 182 E. with line of Charles McAlister 90 feet to beginning. Reserving, however, a strip of land lying on West side of said lot adjoining the lot of T. W. Davis of the width of 8 feet, which is to be kept open perpetually as an alley for the use of Ida L.
