I, J. B. Justice, as Trustee for J. B. Justice and Rachel J. Broadhurst (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Sixty-Five Hundred and No/100- - - - - - DOLLARS (\$ 6500.00), with interest thereon from date at the rate of Five (50)

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as lot 45 as shown on plat of Rutherford Park, recorded in Plat Book P at Page 109, and described as follows:

"BEGINNING at an iron pin on the Western side of Welter Lane, joint front corner of lots 44 and 45, and running thence with joint line of said lots, N. 54-30 W. 188.5 feet to an iron pin; thence S. 27-42 W. 60.6 feet to an iron pin, joint rear corner of lots 45 and 46; thence with joint line of said lots, S. 54-30 E. 179.7 feet to an iron pin on Western side of Welter Lanc; thence with said Lane, N. 35-30 E. 60 feet to the point of beginning."

Being the same premises conveyed to the mortgagor by Otto White, Jr. by deed to be recorded herewith.

The proceeds of this loan were paid as a part of the purchase price for the premises above described.
