NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the West side of Fifth Avenue in Section # 2 of Judson Mills Village, being known and designated as lot # 57 as shown on plat of Sec. 2 of Judson Mills Village, made by Dalton & Meves in November 1939, recorded in Plat Book K at Page 25, and described as follows:

"REGINNING at an iron pin on the Western side of Fifth Avenue, joint front corner of lots Nos. 57 and 58, said pin being 80.6 feet North from the Northwest corner of the intersection of Fifth Avenue and Sixth Street and running thence with joint lines of lots Nos. 57 and 58, N. 85-53 W. 277.5 feet to an iron pin; thence N. 10-16 W. 83.3 feet to an iron pin; thence with the joint line of lots Nos. 56 and 57, S. 83-59 E. 300.9 feet to an iron pin on the Western side of Fifth Avenue, joint front corner of lets Nos. 56 and 57; thence along the Western side of Fifth Avenue, S. 6967 W. 80 feet to the beginning corner."
