NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeast comer of McCrary Street and Cornelia Street (formerly Green Street), being a portion of lots 259, 260 and 261, as shown on plat of M. P. Gridley recorded in Plat Book A at Page 278 and 279 and described as follows:

"BEGINNING at a stake on the Northeast corner of McCrary Street and Cornelia Street and running thence with the Eastern side of Cornelia Street, N. 13-45 E. 138 feet to a stake at corner of property of Callie Mae Leveland; thence with line of said property, S. 76-15 E. 100 feet to stake in line of property of H. W. Smith; thence with the line of said property, S. 13-45 W. 138 feet to stake on McCrary Street; thence with the Northern side of McCrary Street, N. 76-15 W. 100 feet to the beginning corner."
