C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of U. S. Highway Alternate Route # 13, from Greenville to Essley near the Saluda River, and being shown as lot 8 on plat of L. A. Whitmire Estate, recorded in Plat Book Y at Page 87 and described as follows:

"BEGINNING at a stake on the Northern side of U. S. Highway Alternate Route # 13, 350 feet West from a County Road, at corner of lot 7, and running thence with the line of said lot, N. 3-11 W. 200 feet to a stake on a 25 foot alley; thence with the Southern side of said alley, S. 86-49 W. 100 feet to a stake at corner of lot 9; thence with the line of said lot, S. 3-11 E. 200 feet to a stake on the northern side of said U. S. Highway; thence with the Northern side of said highway, N. 86-49 E. 100 feet to the beginning corner. Being the same property conveyed to the mort-gagor by dead recorded in Volume 447 at Page 317."
