"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the West side of Chastain Drive, which intersects N. Franklin Road, and being known and designated as lot No. 7 according to a plat of the property of G. C. Chastain made by W. J. Riddle in October 1951, recorded in Plat Book AA at Page 175 and subsequently revised, described as follows:

"REGINNING at an iron pin on the Western side of Chastain Drive, corner of property of M. W. Being the same premises conveyed to Glenn F. Winchester by deed recorded in Volume 459 at Page 212, Glenn F. Winchester having conveyed an undivided one-half interest therein to Myra P. Winchester by deed to be recorded."
