"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of Pendleton Street, in the City of Greenville, (in the portion formerly known as West Greenville) being shown as lot No. 20 on plat of Davis, Furman and H. J. Haynsworth, said lot fronts 50 feet on the Northern side of Pendleton Street, with a uniform width in parallel line to a deth of 198 feet to an alidey, being the same property conveyed to the mortgagor under the name of Dorothy L.
