"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the Northern side of Fortner Street, near the City of Greenville, being shown as lot No. 16, on plat of New Hope, property of John E. Burden, made by R. E. Dalton, June 7, 1910, recorded in Plat Book A at Page 409, and described as follows:
