C. office for Greenville County in Plat Book K, at page 276, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Main Street at the joint front corner of Lots 34 and 35, and running thence along the joint line of said lots, S. 48-10 E. 160 feet to an iron pin at the rear corner of Lot no. 49; thence with the rear line of Lot No. 49, S. 41-13 W. 115 feet to an iron pin at the joint rear corner of Lots 35 and 36; thence with the joint line of said lots, N. 48-10 W. 161.9 feet to an iron pin on the southeastern side of Main Street; thence with Main Street, N. 42-16 E. 115 feet to the beginning corner; being the same conveyed to me, Ethel M.
