PLAT FARMERS' TRUST MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, Thaurman J. McNeely and Martha Marie McNeely

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Henry W. Goldsberry

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Six Hundred Fifty and No/100

DOLLARS (\$ 650.00),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: Ninety days after date, with interest thereon from date at the rate of Six per cent, per annum, to be computed and paid quarterly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as lot 18, Block G, as shown on plat of Fair Heights, recorded in Plat Book F at Page 257, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin at the Northwest intersection of Brookdale Avenue and Decatur Street, and running thence with Decatur Street, N. 58-40 W. 150 feet to iron pin, corner of lot 17; thence with line of said lot, N. 31-20 E. 50 feet to an iron pin, rear corner of lot 19; thence with line of said lot, S. 58-40 E. 150 feet to an iron pin in Brookdale Avenue; thence with said Avenue, S. 31-20 W. 50 feet to the point of beginning."

It is understood and agreed that this mortgage is junior in lien to a mortgage held by Cely Brothers Lumber Company, Assigned to the S. C. National Bank, Greenville, S.C. in the original sum of \$8500.00.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
