"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of, and known as #843 Buncombe Street, in the City of Greenville, being shown and delineated as lot No. 4-A, Block 1, Page 21 of the City Block Book, and having the following metes and bounds, to-wit:

"BEGINNING at a point on the Western side of Buncombe Street, corner of lot 3, and running thence with the line of said lot in a Southwesterly direction 150 feet to corner of the Griffin lot; thence with the line of said lot in a Northwesterly direction 52 feet to a point in line of lot No. 4-B; thence with the line of said lot in a Northeasterly direction 150 feet to Buncombe Street; thence with the Western side of Buncombe Street in a Southeasterly direction 52 feet to the beginning corner.
