"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, in the north side of the Old Spartanburg Road, and being known and designated as Lot No. 2 of the property of T. L. Greene, and described by courses and distances as follows:

"BEGINNING at a point in the Old Spartanburg Road 300 feet southwest from the corner of the lot sold by T. L. Greene to Fred H. Holcombe by deed dated June 25, 1951 and recorded in the R. M. C. office for Greenville County in Vol. 437, at page 89."
