"BEGINNING at a stake on the western side of Lloyd Street on corner of lot now or formerly owned by T. M. Pickens, and running thence westwardly with his line, 165.25 feet to a stake on line of property now or formerly owned by one Ballenger; thence along Ballenger's line, in a southerly direction, 60 feet to a stake at the rear line of property now or formerly owned by A.
