NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, ON the Western side of Keith Drive (also known as Jameson Road) in the City of Greenville and according to a survey made by Dalton & Neves in May 1947, as revised by Woodward Engineering Company in May 1953 is described as follows:

"BEGINNING at a stake on the Western side of Keith Drive, 357 feet Southeast from S.C. Highway No. 291, and running thence with the Western side of Keith Drive, S. 19-14 E. 65 feet to a stake; thence continuing with said Drive, S. 29-17 E. 56.4 feet to a stake; thence S. 36-35 W. 158.6 feet to a stake; thence S. 33-00 W. 251.6 feet to a stake; thence N. 81-38 E. 184.5 feet to the beginning corner."
