All that certain piece, parcel or tract of land, situate, lying and being in the State of South Carolina, County of Greenville, and in O'Neal Township, School District 11-C, on the West side of the Little Texas Road, containing 12.57 acres, more or less, and having, according to a survey made by W. A. Hester, on August 15, 1944, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of the Little Texas Road at the corner of the 40-acre tract of land purchased by J. M. Nabors from J. E.
