WHEREAS, the said mortgagor ____Elizabeth C. Rouse

each month of each year thereafter the sum of \$ 151.75

to be applied on the interest and principal of said note, said payments to continue up to and including the 15th day of October 1974, and the balance of said principal and interest to be due and payable on the 15th day of November 1974; the aforesaid monthly payments of \$ 151.75

each are to be applied first to interest at the rate of Four and three-fourths 44) per centum per annum on the principal sum of \$ 25,000.00 or so much thereof as shall, from time to time, remain unpaid and the balance of each monthly syment shall be applied on account of principal.
