Whereas, we, the said Mildred V. Kelley and Joe Kelley

and unpaid, the whole amount evidenced by said note to become immediately due, at the option
of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after
its maturity, should be placed in the hands of an attorney for suit or collection, or if before its

on the East side of State Highway # 14 and on the south side of the
Hahn Road, containing 5 1/2 acres more or less as shown on a plat of
the Mrs. V. C. W. Hahn property prepared by H. S. Brockman and recorded
in Plat Book T. at page 390 in the Greenville County R. M. C. Office,
and having according to said plat the following notes and bounds
to wit:

BEGINNING at iron pin in or near the edge of State Highway # 14,
cornering with lands now or formerly of F. M. Todd and runs thereon
with the said State Highway # 14-N. 12-00 E. approximately eight
hundred (800) feet to the center of the intersection of said highway
and the Hahn Road; thence with said Hahn Road (center thereof)
northeasterly five hundred (500) feet to iron pin in said road; thence
S. 12-26 W. eight hundred eighty one (881) feet to iron pin in or
on a neighborhood road on the Todd line; thence with said Todd line
N. 80-30 W. approximately five hundred (500) feet to the beginning
corner, and being bounded on the North by said Hahn Road; East by
