

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Ellen D. McGee, of Greenville County,

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Fourteen Thousand and No/100 - - - -

Dollars, with interest at the rate specified in said note, to be repaid in installments of

any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described preparty, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being shown as all of Lots 6 and 7, of Block K, on plat of Northgate, recorded in the R.M.C. office, Greenville County, S.C. in Plat Book G, at pages 135-136 (revised plat recorded in Plat Book M, at page 13), on the east side of East Avondale Drive, and having, according to a recent survey of the property of Harold R. McGee and Ellen D. McGee, prepared by Piedmont Engineering Service, in August, 1952, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the east side of East Avondale Drive, at the joint front corner of Lots 5 & 6, and which point is 140 feet south of the intersection of Maple Avenue and East Avondale Drive; thence S. 79-20 E. 189.5 feet to an iron pin; thence S. 2-29 W. 141.30 feet to iron pin at joint rear corner of Lots 7 & 8; thence with line of Lot 8, N. 79-20 W. 208.3 feet to an iron pin on the east side of East Avondale Drive; thence with the east line of said drive, N. 10-40 E. 140 feet to point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
