"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the eastern side of Conyers Street (formerly Third Avenue) and being shown as Lot 28 on plat of the property of F. W. Poe Manufacturing Company recorded in Flat Book "Y" at Page 31, and being more particularly described by metes and bounds, as follows:
