Williamson; thence along the line of that lot, S. 43-33 W. 142.7 feet to an iron pin; thence S. 47-13 E. 40 feet to an iron pin, which pin is N. 47-13 W. 86.2 feet from the west side of Aberdeen Drive; thence N. 43-33 E. 142.7 feet, more or less, to a point on the south side of Augusta Road, the point of beginning, subject to a private alleyway over the most southerly 15 feet, more or less, of said property as shown by agreement between J.
