ALSO, all that piece, parcel and tract of land lying and being in Butler Township, Greenville County, South Carolina, containing Sixty-six and 03/100 (66.03) acres, more or less, according to plat thereof made by W. J. Riddle, Surveyor, in February 1948 and revised by the said W. J. Riddle on October 18, 1949 and by C. O. Riddle on March 4, 1954. It is the same land as was conveyed to H. Hoke Smith by Henry McIntyre by deed dated March 19, 1954, recorded in Deed Book 496, Page 265. It is bounded on the North by a 12.52 acre tract of land shown on the plat hereinafter referred to, on the East by H. Hoke Smith, on the South by I. A. Brockman and E. M. Bishop and on the West by E. M. Bishop and a county road and being fully shown on the Riddle plat by courses and distances, which said plat is recorded in Plat Book 12, Page 9, R. M. C. Office, Greenville County, South Carolina, and reference is here made thereto for a more definite and particular description.

ALSO, all that piece, parcel and tract of land lying in Butler Township, Greenville County, South Carolina, containing Sixty-One and 50/100 (61.50) acres, in the aggregate and being made up of two parcels shown on plat hereinafter referred to as 57.50 acres and 4.00 acres, with the two parcels lying together and forming a single tract and being the same lands conveyed to H. Hoke Smith by I. A. Brockman by deed dated April 2, 1954, recorded in Deed Book 497, page 138. It is fully set forth on a plat thereof made by C. O. Riddle, Reg. Land Surveyor, dated November 20, 1953, and revised March 4, 1954. It is bounded by lands now or formerly of Cleveland on the Northeast, other lands of H. Hoke Smith and Lartham Durham on the East; I. A. Brockman on the South; H. Hoke Smith on the West. It is fully shown by courses and distances and metes and bounds on the Riddle plat, recorded in Plat Book 12, Page 5, R. M. C. Office, Greenville County, South Carolina, and reference is thereto made for a more definite and particular description.

ALSO, all that piece, parcel and tract of land lying in Butler Township, Greenville County, South Carolina, on Rocky Creek, containing Seventeen and 46/100 (17.46) acres, more or less, in the aggregate and being made up of three parcels as shown on the plat hereinafter referred to. One of these contains 7.80 acres, another 3.00 acres and the third 6.66 acres and was conveyed to H. Hoke Smith by Lartham Durham and Lilla Durham by deed dated September 23, 1954, recorded in Deed Book 509, Page 17, R. M. C. Office, Greenville County. Described as a whole it is bounded on the North by Cleveland, Rocky Creek being the line; on the East by Rocky Creek; on the South by Durham and on the West by H. Hoke Smith, formerly I. A. Brockman. It is fully set forth by courses and distances and metes and bounds on the plat as made by C.O. Riddle, Reg. Land Surveyor, dated November 20, 1953, recorded in Plat Book 12, Page 5, R. M. C. Office, Greenville County, and reference is made thereto for a more particular and detailed description.
