All that piece, parcel or lot of land situate in the City and County of Greenville, State of South Carolina being known as lot 16 on plat of Pleasant View by C. C. Jones dated February, 1954 and recorded in the R.M.C. Office for Greenville County in Plat Book HH at Page 52 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the northeastern side of Willow Springs Drive, at the joint front corner of lots 15 and 16, and running thence along the line of lot 15, N 63-10 E, 152.9 feet to an iron pin; thence along the line of lot 12, N 31-45 E, 76.6 feet to an iron pin; thence N 55-07 W, 80 feet to an iron pin; thence along the line of lot 17, S 52-25 W, 193.3 feet to an iron pin on the northeastern side of Willow Springs Drive; thence with the curve of said drive, the chord of which is S 34-32 E, 74.8 feet to the point of beginning.
