"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, on the north side of Laurens Road, and being known and designated as Lot No. 3, of the property of Edgar M. West, as shown on plat made by Dalton & Neves, in February, 1942, and recorded in the R. M. C. office for Greenville County in Plat Book L, at page 156, which plat is a resubdivision of Lots 4, 5 and 6, of the property of Alvin T. Waldrep, as recorded in the R. M. C. office for Greenville County in Plat Book K, at page 77, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the north side of Laurens Road, at the joint corner of Lots Nos. 2 and 3, which point is 639.1 feet southeast of the intersection of the Airport Road with the Laurens Road, and running thence along the joint line of Lots Nos. 2 and 3, N. 33-46 E. 243.8 feet to an iron pin; thence S. 77-13 E. 25 feet to an iron pin in the line of property belonging to Conyers & Gower; thence along the line of that property, S. 12-0 W. 111.8 feet to an iron pin, the joint rear corner of Lots Nos. 3 and 4; thence along the joint line of said Lots 3 and 4, S. 33-46 W. 149.8 feet to an iron pin on the north side of Laurens Road; thence along the line of the Laurens Road, N. 55-42 W. 65 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty.
