NOW KNOW ALL MEN, That I/we, the said mortgagor (s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor (s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township on the north side of Iola Street, now within the corporate limits of the City of Greenville, being known and designated as Lot No. 79 of a subdivision known as Donwood as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book A, at page 463, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the north side of Iola Street at the corner of Lot No. 78, which point is 355.8 feet west from the northwest corner of Iola Street and Woodlawn Street, and running thence with the line of that lot, N. 15-20 W. 150 feet to a stake at the corner of Lot No. 84; thence with the line of that lot, S. 74-26 W. 50 feet to a stake at the corner of Lot No. 80; thence along the line of that lot, S. 15-20 E. 150 feet to an iron pin on the north side of Iola Street; thence along the line of said Iola Street, N. 74-26 E. 50 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being the same property conveyed to us by H. Earle Seabern by deed dated April 11, 1946 and recorded in the R. M. C. effice for Greenville County in Vol. 205, page 418."
