MORTGAGE OF REAL ESTATE

COUNTY OF Greenville To All Whom These Presents May Concern: I, Carl B. Holland, of Greenville County, SEND GREETINGS: WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Thirteen Thousand, Five Hundred and No/100 - - - -(\$ 13,500.00) Dollars, with interest at the rate specified in said note, to be repaid in installments of

One Hundred, Thirty-Five and No/100 -. - - - - - - (\$_

One Hundred. Thirty-Five and No/100 -, - - - - (\$ 135.00)

Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN of Three Dollars to me/us the said mortgagor(s) in terms of said note, and also in consideration of the further sum INGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt gain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lots Nos. 32 and 33 of a subdivision known as Chestnut Hills as shown on a plat thereof being recorded in the R. M. C. office for Greenville County in Plat Book GG, at page 35, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northeastern side of Farmington Road, joint front corner of Lots Nos. 33 and 34, and running thence with the joint line of said lots, N. 28-13 E. 145.2 feet to an iron pin at the joint rear corner of Lots Nos. 38 and 39; thence with the rear line of Lots Nos. 39, 40 and 41, S. 60-12 E. 255.4 feet to an iron pin at the joint rear corner of Lots Nos. 32 and 31; thence with the joint line of said lots, S. 66-23 W. 226.4 feet to an iron pin on the northeastern side of Farmington Road; thence with the curve of said road, the chord of which is N. 30-53 W. 65 feet to an iron pin; thence continuing with the curve of said road, the chord of which is N. 55-09 W. 60 feet to the beginning corner, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being two of the lots conveyed to me by Chestnut Hills, Inc. by deed dated January 31, 1955, not yet recorded."

This is a construction mortgage. A lapse of a period of more than 30 days without any construction work being done thereon, or a failure to complete the house within a reasonable time, not to exceed six months, shall constitute a breach of the terms of this mortgage and the holder hereof may institute foreclosure proceedings without delay.
