organized and existing under the laws of the State of South Carolina, a corporation hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eleven Thousand Two Hundred Dollars (\$ 11,200.00), with interest from date at the rate of Four & one-half per centum ($4\frac{1}{2}\%$) per annum until paid, said principal and interest being payable at the office of General Mortgage Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty-two and $\frac{27}{100}$ ----- Dollars (\$ 62.27), commencing on the first day of August, 19 55, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of July, 1960.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate on the North side of Nottingham Road, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 180 on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August, 1951, revised through June, 1953, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "GG", at pages 70 and 71; said lot fronting 80 feet along the North side of Nottingham Road; running back to a depth of 135 feet on the West side, to a depth of 154.7 feet on the East side, and being 82.4 feet across the rear.

This is the same property conveyed to Robert W. Godfrey by deed of L. A. Moseley and John T. Douglas, dated July 15, 1954, recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 504, at page 137.
