"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, about 2 miles northward from the City of Greer, on the north side of the Ballenger Road, containing 4.6 Acres, more or less, according to survey and plat of the R.L.
